Happy Homes Adoption Program: housed, provided veterinary care (including spay/neuter), and found suitable homes for 94 dogs and 143 cats, and in many cases transported adopted pets to their new homes within the Pacific Northwest

4b (Code:) (Expenses \$ 5212 including grants of \$ 5157) (Revenue \$ 0)

Stop the Cycle Spay/Neuter Program: provided spay/neuter vouchers to low-income pet owners who had their choice of participating veterinarians spay and/or neuter their pets. A total of 32 dogs (16 spays, 16 neuters) and 44 cats (28 spays, 16 neuters) were spayed or neutered.

4c (Code:) (Expenses \$ 5378 including grants of \$ 0) (Revenue \$ 0)

Fear No Feral Program: Assisted property owners with humane trapping of 72 cats, which were provided veterinary care, including spay/neuter, ear tipping, and rabies vaccination. Of the cats served, 33 were released at the same location where they were trapped (trap-neuter-release, or TNR); 6 were adopted as barn cats; 28 were transferred to the Happy Homes Adoption Program; 3 are still waiting for homes; 1 was euthanized for health reasons; and 1 died in care.
